Notice Concerning Completion of Series A Financing Round of MiRESSO Co., Ltd.

PACIFIC METALS CO., LTD. (the “Company”) has concluded a capital and business alliance agreement with MiRESSO Co., Ltd. With the funds raised through the Series A financing round, the Company will proceed with the construction of “BETA” at its manufacturing works (Address: 5-2 Toyama Shinden, Kawaragi, Hachinohe City, Aomori, Japan), aiming to commence operations in fiscal year 2027.
